Data Room operating rules

- The Data Room for the acquisition of "Vinyls Italia SpA under extraordinary administration" business units has been set up in the building in Via della Chimica 14 where the Financial department of the Company is located. The data room is allowed to those people who, according the paragraph "Phase 2" of the "Tender regulations of Vinyls Italia S.p.a.'s business units", are defined as "Admitted Bidders"; for confidential reasons the "Admitted Bidders" will be codenamed.
- A Support Room has also been set up in case two prospective "Admitted Bidders" will have to be present on site at the same time.
- Responsible for the Data Room is Gianni M. Balbi, "Vinyls Italia Spa under extraordinary administration" C.F.O., appointed as the Special Administrators' proxy.
- The "Admitted Bidders" are requested to inform the Special Administrators of their intention to visit the Data Room with at least two days notice.
- One "Admitted Bidder" at a time is allowed into the Data Room up to two "Admitted Bidders" are allowed on site and one of them will be allocated into the second room.
- The Data Room and the Support Room have capacity for 4 people each.
- The Data Room will open on September 20th 2010 at 9am and will remain open until October 8th, 2010 at 5pm.
- Regular daily opening times will be from Monday to Friday, 9am to 1pm and from 2pm to 7pm.
- Opening times in hours different from the above will need to be agreed in advance with Gianni M Balbi.
- Upon entering the Data Room, every person representing the "Admitted Bidder", either as an
 employee or a consultant ("Admitted Bidder Representative"), will be logged by Gianni M. Balbi in
 a confidential register after checking the legitimation of such person; the "Admitted Bidders
 Representatives" must refers only to their professional capacity using their codename.
- Upon entering the Data Room for the first time of the "Admitted Bidders Representatives" will be
 distributed an up-to-date Data Room Index, listing the documents which are either already present
 in the Data Room or that can be made available on request.
- Every request by the "Admitted Bidders Representatives" to consult a data item will be recorded in the Data Room Index its checkout and return times and any request for copying will be logged like every request to have copy of the data items.

• the "Admitted Bidders Representatives" are informed that some items are deemed too sensitive and are not available to them for photocopying and removals from the Data Room.

Diego Carmello (General Manager) or Gianni M. Balbi represent the primary interface between the "Admitted Bidders" and the "Vinyls Italia Spa under extraordinary administration" Personnel during the Due Diligence process – this implies that:

- The" Admitted Bidders representatives" have not to record any data using electronic equipments such as cameras, photographs etc. unless authorized by Special Administrators and/or Gianni M. Balbi who will log this request.
- The" Admitted Bidders representatives" have to adhere to safety rules and any other regulations while on site as communicated by the designated "Vinyls Italia Spa under extraordinary administration " representatives.
